1. Jeremy Allin, Chairman

Jeremy has worked as a litigation solicitor with law firm Lester Aldridge for a total of 45 years, retiring in October 2015. He was Chairman of the firm from 2000 to 2010 during which time the firm expanded from Bournemouth to have additional offices in Southampton and London. During the last 20 years of practice, Jeremy had a national practice advising providers of care on regulatory compliance issues and all contentious issues arising from the provision of care including human rights issues and employment issues.

2. Peter Brooks

Peter has had a varied career across a number of different food based industries, most recently he was Vice President for Del Monte Foods International with responsibility for the profitable performance of operations manufacturing and marketing the brand in Europe, Africa and the Middle East which required a knowledge of Human Resources, an understanding of Government Legislation and Union Negotiations.
